Grounds	X	Grounds are well maintained. Trees, vegetation and various bushes around each home were trimmed and there were no notable branches posing a safety risk. This is a vast facility with acres of grass, paved walk ways and roads for cars. There is a large soccer field for activities. Roadways were well maintained with adequate parking. Grounds surrounding each inspected building was in good repair. This vast campus houses academic, manual arts, play grounds and church chapels. There are no significant changes since last reports, however one cottage has been closed as a result of declining population.
Building Exterior	X	Building exteriors were clean and recently painted, back area at Mt. Carmel had garden area for container gardening. Residents are encouraged to participate in growing vegetables in the containers. At this time the gardens are empty. Recent upgrades to gutters was noted. There are cameras on the outside of the building that cover the exterior perimeter. In walking the grounds all buildings appear well maintained. New paint couldn't hurt but do not distract from the overall maintained exterior.

Couches in both homes were torn at the edges and this was noted by staff. There were books and video games readily available. Computers were available for use.

Fights are seen as individual disputes and do not appear to be gang-related.
