MAJOR CONCERNS AND RECOMMENDATIONS

CONDITIONS OF SECURE DETENTION

Are minors provided with orientation?

Yes, at the time they arrive at the station.

Purpose of secure detention:

The purpose of secure detention is to prevent the minor from doing harm to him or herself.

Length of time secure detention expected to last:

Time in secure detention, as is total time in the facility, is kept to a minimum, pending release to a parent/guardian or transport to Juvenile Hall. Total time in detention is expected not to exceed six hours.

Maximum six-hour time limit:

As indicated above the six-hour maximum for total time at the facility is stringently followed. However, in one instance during this report period, after ½ hour in secure detention, the juvenile was detained for

questioning in a homicide case before being transported to Juvenile Hall. In this one instance the juvenile remained at the police station for a total of eight hours.

CONDITIONS OF CELL/LOCKED ROOM

Proximity to adult inmates:

Juveniles are not allowed to be in close proximity to adult offenders. In those instances, in which secure detention is necessary the juvenile is kept in a separate room under the constant supervision of facility staff.

Ability and frequency of staff to supervise minor:

As indicated above, in most cases, an officer remains in the room with the juvenile, if this is not possible there is constant audio and video surveillance of the room.
